All wedding packages (excluding the Selective Photography package) are inclusive of the photographer's time, which includes time with the bride while she is getting dressed, the Ceremony and the reception until all the formalities are completed, (Speeches, guests, cutting the cake, throwing of the garter and flowers and the first dance.)

All packages include a DVD of full resolution photographs that have been edited and finalized in Color, B&W, Sepia, and artistically enhanced.

All the photo books included in the packages are hard covered books with a personalized cover that is UV varnished. Inside pages are printed on 170 GSM Gloss. The books will include various sized photographs put together with various styles of digital scrapbooking and artistic layouts.

TERMS AND CONDITIONS OF SERVICES:

Graphical enhancement which includes sepia, black & white and other creative artistic work form part of my style and the package.

Original/unedited photographs remain the property of the photographer.

Provision for the photographer should be arranged for at the reception, unless otherwise required.

In the instance where the venue is situated more than 100km from the photographer's home, it will be the responsibility of the bridal party to accommodate the photographer.

At least an hour should be allowed for location/creative shoot.

To confirm the photographers services both the clients and photographer will enter into a contract agreement.

Should you accept one of the specified packages or the costing on a package to suite your specific requirements? These terms and conditions will need to be signed. Upon submission of this signed document, an invoice will be forwarded you, upon which your deposit will be required to secure the booking and the services of the photographer and no other enquires will be entertained by the photographer.

A 50% non-refundable deposit is required to secure the booking and the date. This deposit will be deducted from the final balance. Please note that the invoice is only valid for 7 days, where after if no payment has been received, the date, which has been provisionally reserved specifically for you will become available to other prospective clientele.

The balance of the payment is due no less than 5 days before the wedding. Should the balance of payment not reflect in the account by the date of the wedding, the photographer's services and time has been compromised and she will therefore no longer be photographing the event and the deposit has been forfeited as a result. Banking details will be provided upon request.

Upon signature of this contract you also agree that any of the photographs taken can be used by the business for marketing or advertising purposes.

It is the intention of the service provider to ensure that all work as quoted for, is completed between 8-10 weeks after the wedding. I pride myself in the quality and end result of my services and request your patience.

Travelling costs: R2.95/km after the first 50km (which is free)

We regret – no cheques will be accepted.
